

INFORMATIVE REPORT ON THE PRIVACY ACCORDING TO THE PARAGRAPH 13, DECREE NO. 196/2003

Dear Customer,

we would like to inform you that the decree 196/2003 ("Code concerning the protection of personal data") foresees people protection as far as the treatment of personal data is concerned. In compliance with the norm in question, data treatment will be characterized by correctness, legality and transparency as well as by the protection of your privacy and of your rights. In compliance with paragraph 13 of the decree 196/2003, therefore, we provide you with the following information. According to the law in question (ref. Par. 2 - Objective), CAVICEL SpA guarantees that the personal data treatment is carried out while respecting the rights and the fundamental freedom, as well as the dignity of the interested party, with particular reference to privacy, to personal identity and to the right to personal data protection.

Objective of the personal data treatment

All the data communicated by the interested subjects are treated exclusively for the accomplishments connected to the mailing of informative, commercial and promotional material concerning our products.

Communication and data diffusion

Personal data that customers/users have voluntarily communicated to our offices will not be diffused by CAVICEL SpA. Personal data of the interested parties, if necessary, could be communicated to:

- our collaborators and employees in charge of the treatment of such data, for the accomplishment of the above mentioned objectives;
- the post office and the forwarding agents for the mailing/dispatch of documentation and/or material;
- the Authorities to fulfil the law obligations.

In these cases, only the essential data, in the proper measure for the purpose in question, will be communicated.

Nature of the collection and consequences in case data are not provided

The contribution of personal data, even when requiring mere information on our activity/services, is to be considered absolutely as an optional; however, if their contribution is missing, that could cause the non-supply of the services required by the customer/user.

The treatment modality

The treatment of personal data is carried out by using both hard copy and electronic files, with the observance of each possible precautionary measures, in order to grant safety and privacy. Data will be handled and protected in environments whose access is constantly under control.

Owner and manager of the treatment of personal data

The owner and manager of the treatment of personal data is CAVICEL SpA, having its seat in via Caduti del Lavoro 18a, 20096 Pioltello (MI). The Responsible for the data treatment is Mr Celentano Marcello.

Access right to the personal data and other rights (in conformity with par. 7 of the decree No. 196/2003)

The interested party has the right to obtain the confirmation of the possible existence of his/her personal data, even if the same are not registered and their communication is intelligible.

The interested party has the right to obtain the indication:

- of the origin of the personal data, of the purpose and of the methods of treatment.
- of the logics applied in case of treatment carried out by using electronic devices;
- of the identification essential data of the owner, of the responsible and of the representative appointed according to paragraph 5, comma 2;
- by the subjects or by the class of subjects to whom the personal data can be communicated or that could become acquainted as representative appointed in the state territory, as responsible or appointee.

The interested party has the right to obtain:

- A. the update, the amendment or, when required, the data integration; Informativa Privacy ingl.formato Cavicel
- B. the cancellation, the transformation in anonymous form or the blockage of the data treated against the law, including those whose preservation related to the reasons why they have been collected or subsequently treated is not necessary;

The interested party has the right to oppose, totally or partly:

- for legitimate reasons, the treatment of personal data concerning himself/herself, even if pertaining the collection purpose;
- the treatment of personal data concerning himself/herself with the aim of sending advertising material or direct sales material or to carry out market search or commercial communication.

The above mentioned rights could be exercised through a direct request addressed, with no formality, to the owner or to one of the people in charge, even by means of a delegate. The request addressed to the owner or to the person in charge could be sent by registered letter, telefax or e-mail.
